\_\_\_\_\_ The Adopter understands that \$\_\_\_\_\_ shall be made payable to Shiloh Charitable Trust. (Shiloh offers a 30 Day full refund of the adoption fee if adopter finds horse is not a good match. This money back guarantee is for 30 days only. If this clause is used, the Adopter is responsible for expense and labor of getting horse back to Shiloh.)

\_\_\_\_\_ The adoption fees are non refundable and must be paid in full on or before the day of the delivery or pickup of said horse unless another agreement has been made with Shiloh Horse Rescue and Sanctuary.

\_\_\_\_\_ The Adopter agrees to pay for the cost of any pre purchase professional examinations or veterinary exams contracted for by the Adopter. The Adopter agrees to pay for the transportation of said horse to it's new facility unless other arrangements are made for Shiloh to deliver said horse.

\_\_\_\_\_ The Adopter will at his or her own expense, care for said horse in a responsible and humane manner. Shiloh's guidelines for care of said horse include, but are not limited to: adequate shelter, feed, turn out, worming, Farrier work, Veterinary and dental care.

\_\_\_\_\_ In the event Adopter fails to adhere to these guidelines and said horse becomes neglected or abused in the opinion of an independent professional, this agreement becomes void, and said horse will immediately return to Shiloh at the expense of the Adopter.

\_\_\_\_\_ Adopter understands that said horse will have been vaccinated and wormed before adoption. All existing veterinary records will be provided to Adopter upon request.

\_\_\_\_\_ Adopter understands that many conditions of said horse are not obvious, and Shiloh cannot know the details of said horse's history. The responsibility of determining if said horse is fit for use by Adopter belongs solely to Adopter.

\_\_\_\_\_ Adopter agrees to hold Shiloh harmless for any damage, injuries, or death said horse may cause from now and into the future. By adopting, Adopter bears all responsibility of the said horse's actions.
